## “Adventure Land at EDCC”

**Summer Policies:** We are looking forward to a fun summer at EDCC. Please note these policies, as they are set up to help parents, teachers, and children experience the least amount of frustration and the greatest amount of enjoyment!

- Unless otherwise noted- a lunch will be needed each day for the summer. EDCC asks that you pack a healthy and nutritious lunch. NO SODA- please send juice boxes and/or water. We ask that parents do not BRING PEANUT BUTTER OR NUT products into the center due to the fact that we have children with SEVERE allergies.
- We cannot microwave or refrigerate lunches or snacks because of time/space limitations. Food must be ready to eat. You can place cold packs or use thermoses to keep your child's food at your desired temperature.
- EDCC provides two healthy and filling snacks daily. (nutritious, but not a full meal) We offer juice/milk and we encourage the children to drink plenty of water. PLEASE inform the center of ANY FOOD ALLERGIES and/or food restrictions immediately so we can make the proper accommodations for your child. Your child is encouraged to bring bottled water for field trips and outside time.
- Incoming Kinders will have an optional rest period every day we are at the center, while the older students will have quiet time after lunch. \*\* kinder parents please bring in a sheet or a light blanket in as specified every Monday and taken home each Friday to be washed. Bulky items (pillows/stuff animals) are not permitted due to space limitations. **MUST FIT INTO A 2 GALLON ZIP LOCK BACK. YOUR CHILD MAY NOT REST IF THEY DO NOT HAVE THEIR REST SHEETS**
- Walking Shoes (preferably tennis shoes) must be worn every day. We have many scheduled trips and daily physical activities. We want your child to be safe and comfortable as possible. Also, on scheduled water play days your child needs water shoes or shoes that can be worn while getting wet! Due to safety concerns, **ABSOLUTELY NO FLIP FLOPS ( your child may not play at recess or PE if they do not have the proper shoes)**
- **You must be on time for field trips:** We follow a rigid schedule and the buses will not wait. Please be aware of times and dates listed on the calendar, so you can avoid missing field trips. If you are not at EDCC by the time we leave, we assume that your child will not be coming. If you would like to accompany us on field trips, please let Ms. Valencia know in advance to assure a spot on the bus if there is space.
- MAROON EDCC FIELD TRIP SHIRTS must be worn at all field trips- **this allows your child to be visible in a crowd and for their own safety and identification. Additional shirts may be purchased, quantities are limited. IF YOUR CHILD DOES NOT COME IN THEIR EDCC SHIRT THEY WILL NOT BE ALLOWED TO ATTEND THE FIELD TRIP** and asked to go home until they return back with their EDCC SHIRT.
- Please notify the center if your child will be absent or on vacation
- Field Trip Behavior Form- Please review the field trip policy with your child. We EXPECT all children to be on their best behavior. It is important that they understand the importance of being on their best behavior for their safety and the safety of other EDCC students. This also helps to ensure that everyone has the most enjoyable experience. Children who have continual discipline problems will not be allowed to attend scheduled field trips.
- Please apply a liberal amount of sunscreen EVERYDAY before coming to EDCC. We will reapply sunscreen as needed. Due to regulations and allergies, please make sure to bring in a LABELED bottle for your child that will be stored at the center. A medication form must be filled out for each day sunscreen must be applied. If we do not have the form, we cannot apply sunscreen on your child per licensing.

- All EDCC centers close promptly at 6:00 p.m. We ask parents to pick up their child prior to this closing time. It is the parent’s responsibility to arrange for an authorized adult to pick up if the parent cannot be at the center by 6:00 p.m. If a child has not been picked up by 6:30 p.m. and staff has not been able to contact the parents or emergency designee, then we are legally required to contact the Police Department.
- **As of June 1st tuition will be due on the 1<sup>st</sup> and payment (square or checks) will be accepted from the 1<sup>st</sup> of month to the 7<sup>th</sup>. We will continue accepting check payments until end of summer and families using auto bill pay can continue with that option. Any tuition turned in late will be charged a \$45.00 late fee.**

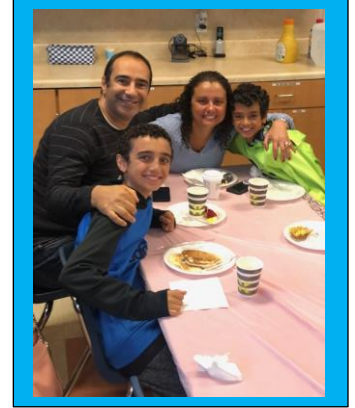

**MEMO: Child’s name and school**

**Drop off and Pick Up:** Parents/guardians must come into the center in the morning to sign their child in to our care and also in the evening to sign the child out. The Sign-in/Sign-out sheet is the legal record of the time a child is in the Center’s care and must be signed using full name clearly written or printed. Proper sign-in and sign-out procedures must be followed to keep us in compliance with our state licensing agency. If someone other than the parent is picking up, a note must be presented to EDCC or a phone call to the Director. Authorized pick-up persons will be required to show identification.

**Withdraw from the program:** A two week notice in writing is required to terminate enrollment. If no notice or less than two-week notice is given, the parent/guardian is subject to paying the contracted fee for the two-week period.
